Solicitation for Letter Intent
Adult Protective Services Program

Central Illinois Agency on Aging, Inc., is accepting “letters of intent” to apply to for the designation of Adult Protective Services Program Provider Agency for Fiscal Year 2023 (October 1, 2022 through June 30, 2023) for the service area listed below:

Geographic Service Area consisting of: Fulton, Marshall, Peoria, Stark, Tazewell and Woodford Counties

Adult Protective Services (APS) is a program to support older adults and adults with disabilities experiencing abuse, neglect, financial exploitation and/or self-neglect. APS case workers will visit the person to conduct an assessment. The assessment helps determine what needs the person may have, help set goals, and explain what services or assistance is available to help the individual meet their goals.

The service provider must adhere to the Illinois Department on Aging’s Adult Protective Services Standards and Procedures and Central Illinois Agency on Aging’s General Service Requirements.

The Applicant must be organized and formally recognized by the Illinois Secretary of State as being a not-for-profit corporation, a unit of local government, or a profit making organization. An Award to a profit making organization requires prior approval from the Illinois Department on Aging. Successful applicants must comply with all applicable prequalification requirements, including but not limited to, current DUNS and SAM numbers, acceptable fiscal management stability, and are in good standing with the Secretary of State and are not on any Debarred/Suspended/Stop Payment listing.

“Letter of Intent” are due at Central Illinois Agency on Aging, 700 Hamilton Boulevard, Peoria, IL 61603-3617 or emailed to ciaa@ciaoa.net on or before 5:00 P.M. on Tuesday, May 10, 2022. The Area Agency on Aging will not respond to a “letter of intent” which is received after the deadline. The Letter of Intent should state the following: (a) services for which Application will be made; (b) service area for which Application will be made; (c) name of the applicant organization and contact person; (d) the email address where the Application and related correspondence will be sent, and (e) the physical organizational address.

Central Illinois Agency on Aging, will forward a proposal package to each agency which submits a timely “letter of intent”. However, submission of a “letter of intent” and receipt of a proposal package does not obligate an agency to continue participation in the procurement. One original copy of the Application must be received by Central Illinois Agency on Aging, Inc. by 5:00 p.m. on Tuesday, June 7, 2022.
